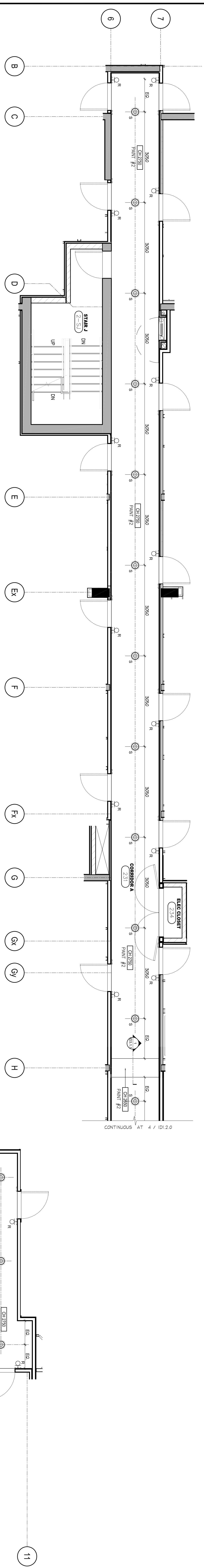

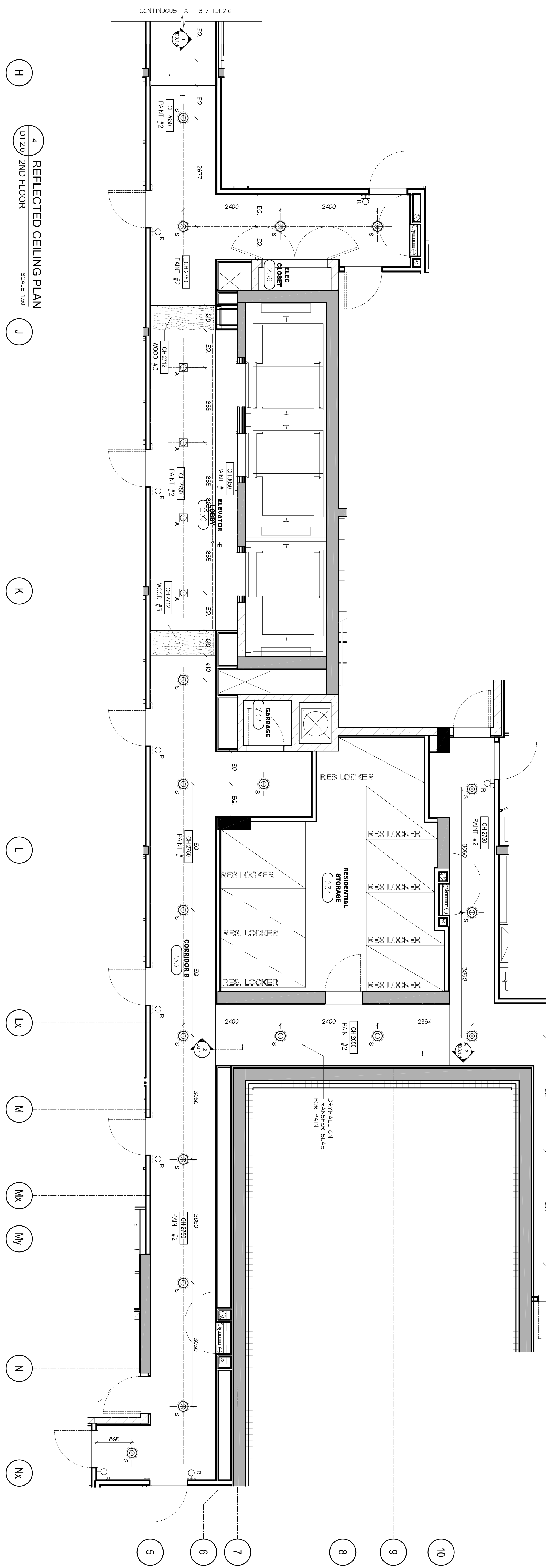
1 CONSTRUCTION PLAN
