**FINISHES NOTES**

- CONTRACTOR TO PROVIDE SWATCHES OF EACH FINISH COLOUR TO B.Y. FOR DESIGNER'S APPROVAL PRIOR TO COMMENCEMENT OF WORK.
- ALL NEW MATERIALS FOR INSTALLATION, FINISHING AND SEALING ARE TO BE DELETED TO MANUFACTURER'S BEST INSTRUCTIONS AND SPECIFICATIONS FOR APPLICATION AND INTENDED USAGE.
- CONTRACTOR TO MAKE SURE GOOD LEVEL AND READY TO ACCEPT INSTALLATION OF ALL FLOOR FINISHES. SOME FLOOR FINISHES REQUIRE TO FINISH LEVEL SURFACE.
- PROVIDE MANUFACTURER'S MAINTENANCE DATA FOR ALL FINISHES TO CLIENT AT THE COMPLETION OF THE PROJECT.
- REMOVE EXCESS ADHESIVE FROM VINYL FLOOR, BASE AND WALL SURFACES WITHOUT DAMAGE, CLEAN, SEAL AND WAX FLOOR AND BASE SURFACES TO FINISHING.
- GENERAL CONTRACTOR TO COORDINATE INSTALLATION OF CARPET WITH INSTALLATION OF OTHER FLOOR AND BASE MATERIALS.
- QUICK RELEASE ADHESIVE IS TO BE USED FOR CARPET INSTALLATION.

REFER TO VENDOR'S INSTALLATION DRAWINGS FOR CORRIDOR CARPET LOCATIONS.
